1. INTRODUCTION

Strategic and conceptual documents of the region constitute an important tool for the implementation of regional politics. They monitor the existing and address the future development of the region with the goal of ensuring its overall balanced and sustainable development.

The most important conceptual document of regional politics on a regional level is the Regional Development Strategy, which is processed and approved by the regional government. The obligation to process it follows from the existing legislative statutes, specifically from Act No. 129/2000 Coll., On Regions and from an updated Act No. 248/2000 Coll., On Support to Regional Development.


Additional importance attributed to the Regional Development Strategy is that it comprises a general framework for issuing compliance and opinions with plans, projects and activities applying for financial support from European, national, or regional funds. It therefore represents an important regional concept with which these plans and projects for the territory of the region must be consistent. The Regional Development Strategy is a general framework for departmental and regional conceptual documents on a regional level.

The Regional Development Strategy of the Liberec Region 2021-2027 is a conceptual regional policy document of Liberec Region for the period of 2021-2027 and its goal is to propose activities, that will not only lead to meeting the objectives of the regional policies on an EU and Czech Republic level, but foremost to troubleshooting, covering the established needs and to balancing development of the entire Liberec Region.

The approach to processing the Strategy, in which a great space was dedicated to working with the public within thematic working groups, has received an award for good practice in strategic planning with public from the Healthy Cities of the Czech Republic.

Strong and cooperating touristic areas, together with business, non-profit and public sectors are creating high quality conditions for tourism, which takes the encumbrance on the territory into account.

Tourism is seen as an important part of economy: it employs qualified and motivated employees with language skills.

The residents of the Liberec Region know their region to be a unique place for a leisure time, on weekdays as well as on weekends. There is a mutual respect between the visitors and the residents.

The residents and the visitors of the Liberec Region spend their leisure time with sport, while taking advantage of the favourable natural conditions as well as the diverse offer of affordable and economically self-sufficient sports grounds. The sports grounds are in a good technical condition, they meet the hygienic conditions, correspond to the modern trends and are available to all ages as well as to the handicapped.

People working in the sport field are motivated and qualified. The sport management system is based on a cooperation of the regional sport authorities. Leisure time activities are implemented also in primary schools to ensure fundamental movement skills in children and young people and to increase their movement literacy.

The conditions for the sport of the general public are created, as well as the conditions for holding important national and international sporting events.

Preserving cultural heritage and making it accessible is a societal interest. A guarantee for the preservation, development and recognition of the culturally-historical heritage are educated and experienced people working in the area of culture and historic preservation, and a public, which can exploit the potential of the cultural heritage of the region and has established a positive relationship towards it.

A varied offer of cultural experience for the public, including the activities exceeding borders of the region, is created by active and educated people from the public and private sector, cultural institutions, members of associations and citizen's initiatives, supported by the local government.

C1 RELIABLE TRANSPORTATION

VISION

Well-equipped, safe, and high-level road and rail network is adequately interconnecting the whole Liberec Region and allows for easy and quick reachability to neighbouring regions and to Prague while minimizing the negative impact on the environment and people. The transit transport is fitted to the region. High-level and safe transport systems are coordinating the transport on the principle of sustainable mobility, thereby gradually lowering the traffic congestions within the cities and municipalities.

Content residents and visitors of the region are using the non-motorized transportation which is based on quality and optimally separated infrastructure connected to other types of transport. Sharing means of transport and using smart solutions is a common part of life.

It is automatic for everyone to use public transportation for most of their journeys, because it is reliable, attractive, barrier-free and offers good and well interconnected connections, and therefore is able to compete with individual transportation.

3. DOCUMENT'S LINK TO THE ISSUE OF CLIMATE CHANGE AND SMART SOLUTIONS

CLIMATE CHANGE

The topic of climate change is becoming more and more relevant in recent years. Despite the opinions on this process varying, the signs of this change cannot be questioned. The Liberec Region is prepared to mitigate the impact of climate change on its territory and is searching for possibilities for an active cooperation in reduction of greenhouse gas emissions. With a timely implementation of suitable adaptation measures the region wants to strengthen the long-term resistance against the impacts of this global change. It is continuously adapting towards the most recent development in a way which preserves good living conditions as well as the region's potential, not only for the current generation but also for the future generations.

SMART SOLUTIONS

The concept of "Smart Cities" has come into use and started to develop in the Czech Republic in 2010, mainly in the initiative focused on industry, transport, and energetics and on lowering their ecological burden. Therefore, in Czech language the word "smart" has often been replaced with the words "intelligent" or "clever".

Nowadays this concept is used in a much broader approach - smart cities, smart municipalities, smart rural areas, smart public administration, smart landscape, smart networks etc. They all have a common goal, to ensure a quality life to the residents and a development of municipalities, cities, and regions with the help of modern technology.

The Liberec Region too, professes to this idea and has taken the first step in enforcing it by compiling a conceptual document, Smarter Region, which should help direct future activities of the Liberec Region in the area of utilizing smart technologies. The main goal is to propose a vision and an area of intervention which will react well to the real needs of the Liberec Region residents, as well as identifying areas in which it makes sense to pursue an application and future systematic use of information and communication technologies. Primarily the concept is focused on the topics connected to the competencies and responsibilities of the Liberec Region as a public corporation, which according to the Act on Regions "cares for a versatile development of its territory and for the needs of its residents." Technologies and smart solutions are not seen as a goal, but instead as means to facilitate and simplify the process of solving the issue, save people time and energy and increase work productivity as well as the level of awareness on this issue.

4. CONCLUSION

The Regional Development Strategy is a strategic document that addresses the future development of the region in its broadest context and therefore represents an important basis for regulating its territorial development during the next 7 years. The document has been processed and approved by the regional government.

WHY DOES THE REGIONAL GOVERNMENT NEED A DOCUMENT LIKE THIS AND WHY DOES IT PROCESS IT?

The regional government should be deciding on the future development of the region based on its knowledge of the current state of the area and its needs and on the approved documents discussed with important partners in the territory, to ensure that its decision is not arbitrary, ineffective or in conflict with the principles of strategic regional management and planning. The strategy should therefore serve the autonomous regional authorities as a basis for implementing decisions about the future development of the region. In addition, the obligation to process this document is also required by legislation, specifically in Act No. 248/2000 Coll., On Support to Regional Development and Act No. 129/2000 Coll., On Regions

To ensure that the development strategy is not solely a document relevant to the regional government, but a document on which all the important entities that influence the development of the region will agree, the processor of the document dedicated a relatively large effort to also involve entities from outside the Regional Authority and the public of the Liberec Region, not only during the process of its discussion but even beyond the obligations arising from the legislation, which is commonplace for the Liberec Region, but also during its actual processing. Approximately 300 people involved in 14(5) working groups created the foundation for the proposal section of the programme, which was gradually modified and specified, based on several rounds of negotiations with various authorities of the Regional Authority of the Liberec Region and other bodies of the Liberec Region, but also with external entities including the wider public.

WHAT IS OUR EXPERIENCE OF COOPERATING WITH THE PUBLIC?

The process of drafting and discussing the Regional Development Strategy of the Liberec Region confirmed that engaging with the public in the process of creating the document from the very beginning is very important. Though this is a fairly laborious way of working, demanding in the area of communication and also in terms of the necessity of compliance with pre-defined rules and of mutual trust and openness, it also has a number of benefits:

- from the beginning, the public has the opportunity to co-create the document and project its ideas about the future development of the region, its own needs and its views concerning life in the region into it,
- many new contacts are established, and experience is shared which will contribute to a further improvement of cooperation in the region,
- space for discussion is provided as well as for the refinement of ideas and for finding common solutions across departments, institutions, public administrations, interest groups and the wider public.

IN PRACTICE, HOW WILL THE STRATEGY BE UTILISED?

The Regional Development Strategy of the Liberec Region 2021-2027 constitutes a general framework for projects or plans that should be implemented in the region and that will compete for its support during the period of 2021-2027. In practice, this means that the prepared plans, projects, or other proposed activities will need to be compatible with the activities proposed in the regional strategy. The so called "Compliance with the Regional Development Strategy" is a document that, as for the 2014-2020 period, will be issued by the Department of Regional Development and the European Projects of the Regional Authority of the Liberec Region. The strategy also provides a general basis for the acquisition and the creation of other conceptual documents in the region, microregions, municipalities, and more (e.g. Development Principles of the Liberec Region, A Medium-term Plan for the Development of Social Services, A Regional Innovation Strategy, the development strategies of the LAGs, the municipalities, the cities, etc.).

One of the main conditions for the Regional Development Strategy to be accepted as a meaningful document, and one that could be implemented, is the consensus of decision-makers in the area concerning its content. We believe that the method of its processing together with the subsequent negotiation process concerning the Regional Development Strategy of the Liberec Region 2021-2027 make it a good choice and that the document will constitute a reliable support for the Regional Management's decision-making and also a guide for other entities who care for the all-round and balanced development of the Liberec Region.
